**Product Description**

9% Zinc EDTA is a fully chelated, liquid micronutrient specifically formulated to resist tie-up once blended with other liquid fertilizers. It can be mixed with most liquid fertilizers (except aqua ammonia) and suspensions for both soil and foliar applications when crop needs require zinc. 9% Zinc EDTA is recommended for crops that require high zinc usage, such as but not limited to corn, edible beans, onions, rice, and potatoes.

**General Application and Use Recommendations**

9% Zinc EDTA is generally compatible with fertilizer solutions. Proper timing, rate, and placement is important for desired results and highly dependent on stage of crop growth, soil fertility levels, and environmental conditions. Applications made to soil should be incorporated. Foliar applications should not exceed recommend rates. When applying through an irrigation system, apply within 2 weeks of planting and before flowering for best results. Always make a small-scale test (jar test) to assure compatibility in your material. See recommendation sheet for full label recommendations.

**Handling and Storage**

9% Zinc EDTA should be stored in a cool, well-ventilated location in vented tanks out of direct sunlight. Avoid containers, piping, or fittings made of aluminum, brass, bronze, or copper bearing alloys. Spills from broken containers can be cleaned up with absorbing clay or other suitable materials. Avoid inhalation of vapors if possible. Avoid contact with skin and eyes. Wear proper protective equipment when handling. Dispose of used containers in accordance with local, state, and federal regulations. Keep out of reach of children.
